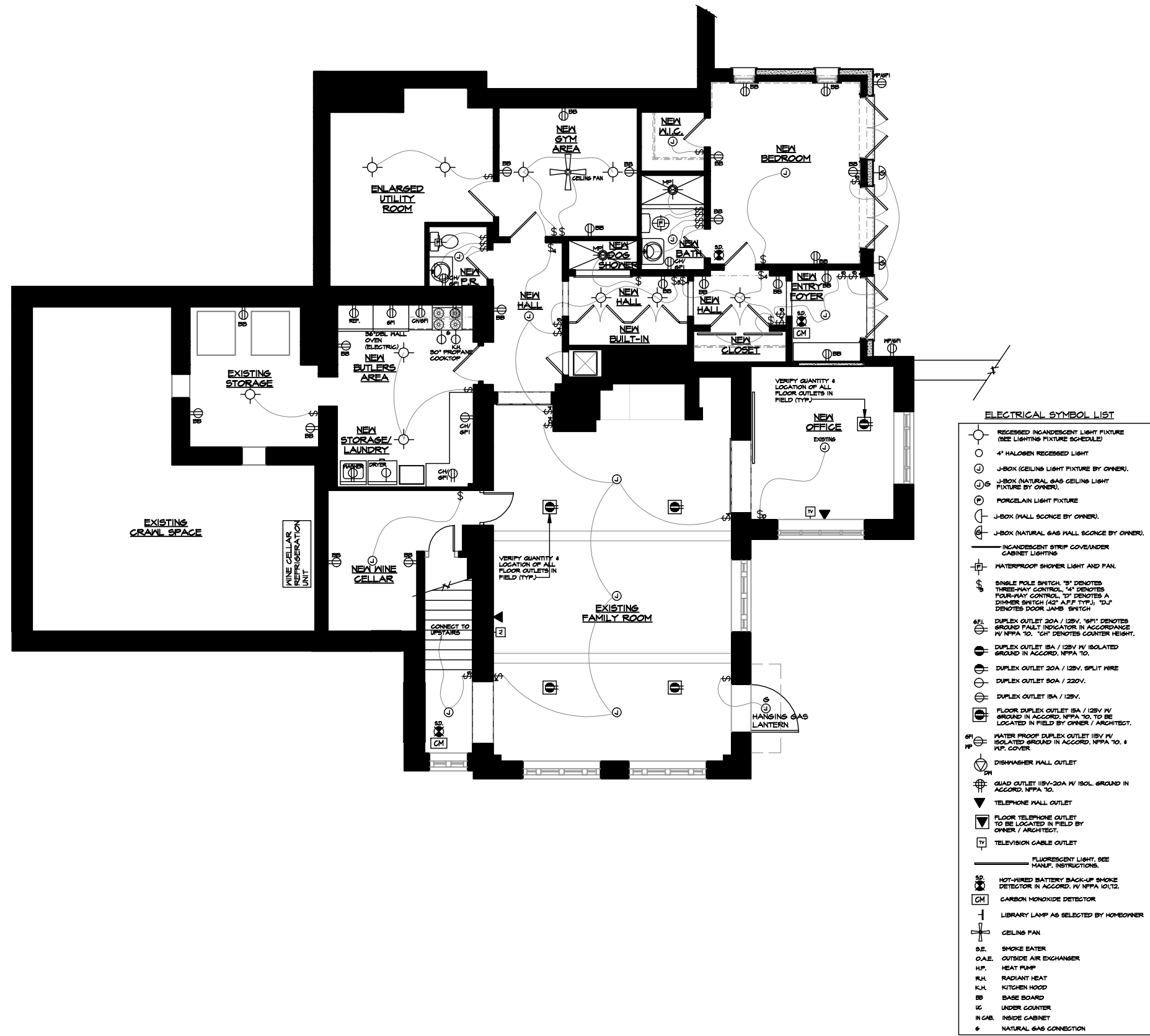

 - ⊕ DISHWASHER WALL OUTLET
 - ⊕ QUAD OUTLET 115V-20A W/ ISOL. GROUND IN ACCORD. NFPA '10.
 - ⊕ TELEPHONE WALL OUTLET
 - ⊕ FLOOR TELEPHONE OUTLET TO BE LOCATED IN FIELD BY OWNER / ARCHITECT.
